# **CHI St. Joseph's Health Receives Patient Safety Improvement Award**

PARK RAPIDS, MN (May 7, 2015) – CHI St. Joseph's Health received the 2015 Minnesota Hospital Association (MHA) Award for superior performance in patient safety Improvement at the 31<sup>st</sup> annual awards ceremony.

CHI St. Joseph's began its journey toward zero serious safety events in earnest in 2011 with the implementation of the SafetyFirst program. They have been actively engaged in implementing MHA's safety best practices and numerous other initiatives. This has included the creation of safety coaches throughout the organization; Error Prevention Techniques training for all new staff; implementation of daily safety huddles; safety rounding by senior leadership; and the active engagement of CHI St. Joseph's Patient and Family Advisory Council to review and discuss safety and quality outcome data and provide input.

"CHI St. Joseph's Health is fortunate to have providers, nurses and support teams committed to providing excellence for our patients every day," says Deb Haagenson, Vice President of Patient Care.

MHA president and CEO, Lawrence Mass further notes: "CHI St. Joseph's Health is helping to further strengthen patient safety and have set the bar high for patient care and for meeting the needs of their community."

CHI St. Joseph's is the recipient of six patient safety awards for implementing best practices and was one of the first eight hospitals in the state to earn the MHA Patient Safety Excellence Award for its achievement in the Hospital Engagement Network. Since 2011, near miss reporting has increased by 86 percent and the serious

safety event rate has decreased from 4.25 per 10,000 adjusted patient days in 2011 to 1.55 in 2014.

"This is a special accomplishment and demonstrates the commitment and priority we place on patient safety and quality improvement in all service areas at CHI St. Joseph's Health," says Chris Broeker, Director of Quality.
